乘客乘搭九龍巴士(一九三三)有限公司(下稱"九巴")指定九巴獨營過 海路*(下稱"該指定過海路線")於港島轉乘進智公共交通控股有限公司 (下稱 "進智公交") 指定港島專線小巴路線 [#](下稱 "該指定專線小巴 路線");或乘搭該指定專線小巴路線於港島轉乘該指定過海路線,即可 享有港幣 \$1.0 成人車資優惠 (包括持有「學生身份」個人八達通乘客)。 優惠期至 2021 年 6 月 30 日。

優惠須受以下條款與細則約束:

Passengers can enjoy the KMB-AMS interchange discount when interchanging from the designated cross-harbour routes solely operated by The Kowloon Motor Bus Co. (1933) Limited ("KMB")* ("Designated Cross-harbour Routes") to designated Hong Kong Island Green Minibus routes operated by AMS Public Transport Holdings Limited ("AMS")# ("Designated Green Minibus Routes") or from the Designated Green Minibus Routes to the Designated Cross-harbour Routes. The discount is HK\$1.0 for adult (including valid holders of a personalised Octopus card with student status). The concession scheme is extended until 30 June 2021.

Subject to the following terms and conditions:

- 1. The discount is only applicable if boarding at the Designated Cross-harbour Routes in Kowloon or the New Territories The discount is only application: In obtaining at the Designated Cross-harbour Routes in Nobles in Nobles
- Pursuant to paragraph 1 above, passengers must interchange (1) from the Designated Cross-harbour Routes to the Designated Green Minibus Routes within 180 minutes from the time they pay the fare for the first leg and such first leg transaction must be recorded on the same Octopus card in order to enjoy the discount; or (2) from the Designated Green Minibus Routes to the Designated Cross-harbour Routes within 180 minutes from the time they pay the fare for the first leg and such first transaction must be recorded on the same Octopus card in order to enjoy the discount. The fare discount will automatically apply to the 2nd leg fare.
- Children under 12 and senior citizens aged 65 and over, or passengers enjoying the "Government Public Transport Fare Concession Scheme for the Elderly and Eligible Persons with Disabilities" will not be eligible for this interchange discount

 Passengers must maintain a positive balance in their Octopus card in order to enjoy the offer.

 To enjoy the discount, passengers should not use the same Octopus card on other bus routes or on other modes of transport between the two legs. The passenger's Octopus card should not have more than 9 transaction records between
